



Rate Changes to Maryland Residential Customer Bills

Effective June 1, 2009, Delmarva Power's supply rates have increased based on a schedule approved by the Maryland Public Service Commission (MDPSC). The new rates will increase the typical residential customer's summer bill by about 2.6%, or \$4.38, a month. Delmarva Power used a competitive bidding process under the regulatory oversight of the MDPSC to purchase power on behalf of its Maryland customers and the supply prices have been reset based on the lowest bids.
