

## Rate Changes to Maryland Commercial & Industrial Customer Bills

### *New rates to take effect June 16, 2008*

Effective June 1, 2008, Delmarva Power's Standard Offer Service (SOS) supply rates have changed based on a schedule approved by the Maryland Public Service Commission (MDPSC). Delmarva Power used a competitive bidding process under the regulatory oversight of the MDPSC to purchase power on behalf of its Maryland customers and the SOS supply prices have been reset based on the lowest bids. Total bill impact will vary by rate class and usage.

Additionally, effective June 16, 2008, distribution rates decreased as a result of a final rate adjustment approved by the MD PSC in Delmarva Power's distribution rate case.
