

NEW ELECTRIC RATES TAKE EFFECT FOR DELAWARE CUSTOMERS

Rates for Standard Offer Service (SOS) changed effective June 1, 2021 for our Delaware electric customers. If you have not chosen an alternative electricity supplier, you are an SOS customer and Delmarva Power buys electricity for you. The impact to commercial and industrial customers will vary. The SOS rate can be found in the Supply Charges section of your bill.

See the chart below for the new SOS rates, including a comparison of summer and winter rates. Please note that summer rates take effect with the billing month of June. Delmarva Power, as with many other utilities, charges different rates for electricity use in the summer (June–Sept) than it does in the winter (Oct–May).
