

NATURAL GAS SUPPLY RATES CHANGE FOR DELMARVA POWER DELAWARE CUSTOMERS

The Delaware Public Service Commission approved several changes in gas supply rates for Delmarva Power Delaware customers. These changes will take effect on Nov. 1, 2021.

- The Gas Cost Rate (GCR) is increasing.
- The GCR is adjusted annually based on the forecasted wholesale prices of natural gas for the coming year.
- For applicable service classifications, the pressure support fee is increasing, however the balancing fee is decreasing.

Please review the chart below for new rates. Effects of these changes will vary with your service classification and your usage.
