

Important Rate Information for Residential Electric Customers

Delmarva Power asked the Delaware Public Service Commission (Commission) for an increase in electric delivery rates to recover the costs of reliability and smart-infrastructure investments that have helped reduce the frequency and duration of power outages. A portion of the rate increase went into effect on an interim basis effective July 16, 2016.

How does this rate change affect me?

- Effective December 17, 2016, an additional portion of the increase will go into effect on an interim basis. Residential customers who use 1,000 kilowatt-hours of electricity per month will see their bill increase 4.68 percent or \$6.23 per month.
- The ultimate amount of the rate change must be approved by the Commission. If the full proposed rates are approved, customers who use 1,000 kilowatt-hours of electricity per month will see their bill increase 7.25 percent or \$10.23 per month.
- The rate increase is subject to refund to customers, with interest, if the Commission's final approval of the electric delivery rates is less than the rates implemented. The Commission is conducting a thorough review of this proposal and we will notify you by mail of any changes.

What else can I do to help manage my energy costs?
